Billet subspecialty coding is to be based on the minimum education/training/experience level required for optimum performance. Supply Chain Management/1302 subspecialty coding is justified when, in addition to the general criteria stated in NAVPERS 15839 series (Manual of Navy Officer Manpower and Personnel Classification) Part B, the following specific criteria are satisfied:

1. Subspecialty Coding Restrictions: Billets assigned to:
Supply Corps Officers
2. Applicable Officer Designator(s): Billets assigned to:
Supply Corps Officers
3. Applicable Billet Designator(s): 31XX
4. Educational and Significant Experience Criteria. Coded billets are authorized when the functions of the billet include the CSR competencies listed above. For additional clarification regarding definition of suffixes, refer to the NAVPERS 15839I, Vol 1.

Note: 'Proven' requires at least 18-month experience tour in subspecialty-coded billet. Authorized suffixes are annotated "X" for yes; unauthorized suffixes are blank.




