SUBJECT: Approval of February 2020 O-6 and O-5 & Below Experience-Based Joint Duty
Assignment Review Board Recommendations

1. On 11 February 2020, the Joint Staff convened an O-6 Experience-Based Joint Duty Assignment (E-JDA) review board. On 12-13 February 2020, the Joint Staff convened an O-5 & below E-JDA review board. Both boards were held in accordance with Chairman of the Joint Chiefs of Staff Instruction (CJCSI) 1330.05A, 15 Dec 2015, "Joint Officer Management Program Procedures." The boards considered 48 O-6 and 344 O-5 & below joint experience nominations, submitted by officers via their respective Services, for joint credit.
2. The recommendations of the boards (Attachments A and B) are hereby approved as follows: 30 O-6 and 280 O-5 & below submissions are approved to receive joint experience points; 15 O-6 and 62 O-5 & below submissions are disapproved; and 3 O-6 submissions and 2 O-5 & below submission are returned for rework to be considered at a future board.
3. Attachment C lists seven officers who have successfully completed their first or second tour in the Afghanistan/Pakistan Hands Program. In accordance with CJCSI 1630.01B, 8 July 2016, "Afghanistan/Pakistan Hands (APH) Program," enclosure D, officers will automatically be awarded experience points.
